TREASURER'S REPORT

Treasurer Somheil reviewed the Consolidated YTD Revenue and Expenditures report through April 2023 which represents completion of 33% of the fiscal year, noting that total revenues are 53% of budget. Revenues include both the Malinowski bequest and funds received from the Michel Trust. On the expense side, operating revenues are at 27% of budget, capital expenditures at 5% of budget which results in total expenditures at 24% of budget. Trustee Rusk inquired about the note indicating that amounts for Salaries and Employee benefits are estimated. Ms. Doubek replied that the City Finance Department is not current in recording actual expenditures and so these are estimated based on ADP payroll reports. Director Bertucci clarified that although the Library is running its own payroll, the related expenditures are still booked to the Library's General Ledger through manual journal entries. President Hanba noted that the City has posted the application for Library Board trustees and applications are due May 30, 2023. Director Bertucci added that the Library will post this on our social media platforms as well.

SECRETARY'S REPORT

Secretary Powers reviewed the Secretary's report included in the packet on page 13, noting Library website News items and a press article about the Illinois Libraries Present program. Also noted was the letter of appreciation received from the DuSold family for use of the first floor meeting room for Mr. DuSold's memorial service, and another letter from the Secretary of State, recognizing National Library Week and the value of libraries.

DIRECTOR'S REPORT

Director Bertucci noted additions to her report which begins on page 19 of the packet.

- CVI has deployed cyber security training to all email addresses at parkridgelibrary.org. including to trustee emails.
- The Library has developed a partnership with the Chicago Botanic Garden to provide programming for teachers. This supports our strategic plan initiative to support educators and home school families.
- The blood drive held here in April in partnership with Verity was the most successful to date. The next event will be held here on June 3 in support of a local resident and in partnership with that family.
- The field work portion of the FY22 audit has been completed and when the audit report is ready, Director Bertucci will schedule a presentation of the report for a Budget & Finance Committee meeting.
- A number of technology projects are currently underway in the building while at the same time, planning is underway for building projects that will occur in late summer/early fall.
- The City's Historic Preservation Committee partnered with the Library this month in honor of National Historic Preservation month by sponsoring a display in the second floor exhibit case and also a program on local landmarks and their stories.
- Statistics for the year are generally moving in a positive direction as the Library heads into its busiest season with the start of Summer Reading Clubs.

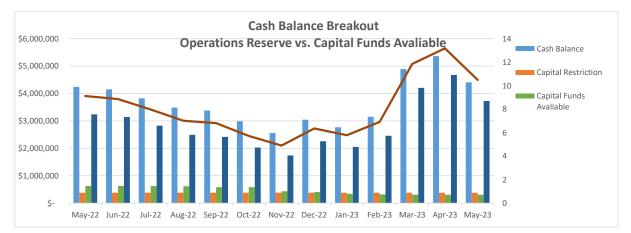

Subject:	Non-resident Library Card Fee

Background:

The Library sells library cards to non-residents that live in areas not taxed for public library service according to the <u>laws</u> of the <u>State of Illinois</u>. Cards sold to non-residents provide all of the privileges of a resident library card and may be used at other libraries within the RAILS library system. The fee is determined using a mathematical formula provided by the State to calculate a fee equivalent to the average local tax support.

The State requires the Library Board of Trustees to annually review the fee for a Non-Resident Library Card and authorize selling library cards to non-residents.

Based on the Library's anticipated tax receipts for Fiscal Year 2023, I recommend the Non-Resident Library Card Fee be \$284, effective July 1, 2023 and that the Committee approve the attached resolution so it can go to the Board for approval on June 20, 2023.

2023 ANNUAL RESOLUTION AUTHORIZING PUBLIC LIBRARY NON-RESIDENT CARDS

Whereas, the Park Ridge Public Library is a tax-supported public library; and

- Whereas, people residing within the jurisdictional boundaries of the Park Ridge Public Library pay taxes to support the Library, and so need pay no additional fee to be eligible to receive a library card; and
- Whereas, Section 5/4-7(12) of the Local Library Act stipulates that "A person residing outside of a public library service area must apply for a non-resident card at the public library located closest to the person's principal residence"; and
- Whereas, the Office of the Illinois Secretary of State has issued regulations defining the "closest public library" and also providing three formulae which public libraries can use to determine the non-resident fee; and
- Whereas, the Library Board of Trustees of the Park Ridge Public Library has determined for the period commencing January 1, 2023 and ending December 31, 2023, to participate in the non-resident reciprocal borrowing program of its regional library system and to issue non-resident library cards;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE LIBRARY BOARD OF TRUSTEES OF THE PARK RIDGE PUBLIC LIBRARY as follows:

- Section 1: Individuals residing beyond the jurisdictional boundaries of the Park Ridge Public Library whose closest public library is the Park Ridge Public Library, and not residing within the boundaries of another public library and owning or leasing no taxable property within the jurisdictional boundaries of the Park Ridge Public Library, may purchase a one year nonresident fee card for the price of \$284.00 effective July 1, 2023, calculated by the General Mathematical Formula (23 Ad. Code 3050.60(a)),
- Section 2: Individuals residing beyond the jurisdictional boundaries of the Park Ridge Public Library, but owning or leasing (as an individual, a partner, the principal stockholder, or other joint owner) taxable property within jurisdictional boundaries of the Park Ridge Library, or serving as a Senior Administrative Officer of a firm, business or other corporation owning or leasing taxable property within the jurisdictional boundaries of the Park Ridge Public Library, notwithstanding anything to the contrary in this Resolution, may obtain a non-resident library card without payment of the non-resident fee upon presentation of the most recent tax bill upon that taxable property.Each nonresident library card issued pursuant to this Section is limited to the exclusive use of the individual whose name appears on its face.
- Section 3: The President of the Library Board of Trustees shall notify the regional library system in writing within 30 days of the adoption of this Resolution, stating (a) the effective date of this Resolution, (b) the beginning and ending dates of the 12-month period of validity for non-resident library cards issued pursuant to this Resolution, and (c) the fee formula as set forth herein.
- Section 4: The Park Ridge Public Library shall continue to honor all non-resident library cards heretofore issued by the Library, for the full term of purchase.

- Section 5: The Park Ridge Public Library shall cooperate with other participating area public libraries, the regional library system and adjacent regional library systems to determine the appropriate non-resident service areas, as stated in 23Ad. Code 3050.25.
- Section 6: The policy of the Park Ridge Public Library for service to non-residents, including a description of the Library's service areas and the methods of calculating fees, shall be available for public inspection at the Library.
- Section 7: A valid non-resident library card issued by the Park Ridge Public Library pursuant to this Resolution shall accord a non-resident library cardholder all the services which this Library provides to its residents, including reciprocal borrowing privileges.
- Section 8: No non-resident is eligible to receive a "local use" library card from the Park Ridge Public Library.

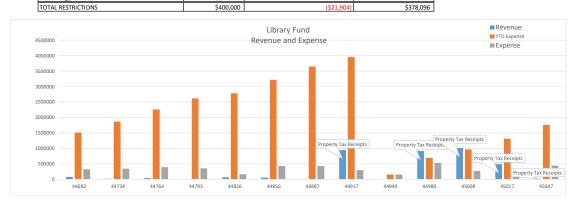

Measure aimed at preventing book bans at public libraries signed into law by Gov. J.B. Pritzker

Public libraries in Illinois could be cut off from state funding if they remove books and other materials from their shelves for "partisan or doctrinal" reasons under a measure signed into law Monday by Gov. J.B. Pritzker. "Book bans are about censorship, marginalizing people, marginalizing ideas and facts," Pritzker said before signing the legislation at the Harold Washington Library in Chicago. "Regimes ban books, not democracies. Nazi Germany, fascist Italy, the Taliban's Afghanistan. We refuse to let the vitriolic strain of white nationalism coursing through our country determine whose histories are told."

The measure passed through the state House and Senate along party lines during the spring legislative session as debates over book banning have amplified partisan divides nationwide and provoked intense discussions about censorship, school curricula and how much say parents should have over what titles are on library shelves. Democrats say book bans often discriminate against the LGBTQ community and other marginalized groups, while Republicans have argued that some titles need to be out of the reach of children if they contain pornography or obscene imagery.

Democratic Secretary of State Alexi Giannoulias, who is also the state librarian and who initiated the legislation, said the battles over censorship have made librarians and their workplaces targets.

"These radical attacks on our libraries have divided our communities and our librarians have been harassed, threatened and intimidated for simply doing their jobs," said Giannoulias, whose office provides grants to the state's public libraries. "Parents, and only parents, have the right and the responsibility to restrict their children's, and only their children's, access to library resources."

During debate on the bill in the Democratic-controlled Illinois General Assembly, Republicans raised concerns that the measure would take away control from local governments, including library boards, over what books belong on shelves.

Democratic state Rep. Anne Stava-Murray of Downers Grove, who sponsored the bill in the House, said she found a local control argument made by a GOP House member "disgusting."

"Local control has long been a dog whistle for allowing statewide or nationwide racist or bigoted policies to persist," she said on the House floor, drawing groans and boos from Republicans.

Republicans also expressed concern over potentially harmful content. State Sen. Jil Tracy of Quincy asked how a library would be able to prevent pornographic materials like "Hustler" magazine from falling into the hands of underage readers.

Democrats responded by saying this bill only concerns books banned for partisan reasons and doesn't change existing rules around managing adult or harmful content.

Giannoulias on Monday reiterated that the measure would not interfere with a library's book selection process, but would only affect libraries that pull books from shelves for "partisan or doctrinal" reasons.

Tracie D. Hall, executive director of the Chicago-based American Library Association, said the law signed by Pritkzer is the first of its kind in the United States.

"I could not be prouder that the American Library Association ...makes its home in a state that is first in the nation to create a law that stands up to censorship and calls it what it is: a threat to education ...and a threat to our



democracy," Hall said.

Illinois has not seen as many cases of book bans or attempted bans as states that lean Republican, according to research from PEN America, a New York-based literary advocacy group. But, citing figures from the Chicago-based American Library Association, Giannoulias' office said there were 67 attempts to ban books in Illinois in 2022, up from 41 the year before.

By signing the bill, Pritzker, widely seen as having presidential ambitions, again staked out his liberal credentials and offered a stark contrast to potential Republican rivals like Florida Gov. Ron DeSantis, who is vying for his party's 2024 presidential nomination.

DeSantis has vowed to end "woke" ideology and has taken action to remove books from Florida schools he has found inappropriate. In his remarks Monday, Pritzker took a thinly veiled shot at DeSantis and like-minded governors.

"While certain hypocritical governors are banning books written by LGBTQ authors, but then claiming censorship when the media fact-checks them, here in Illinois we are showing the nation what it really looks like to stand up for liberty," Pritzker said. "As simple as that."

Administration & Board

- On Monday, June 12 Governor Pritzker signed HB2789 in to law, amending the Illinois Library System Act to include the following:
 - In order to be eligible for State grants, a library or library system shall adopt the American Library Association's Library Bill of Rights that indicates materials should not be proscribed or removed because of partisan or doctrinal disapproval or, in the alternate, develop a written statement prohibiting the practice of banning books or other materials within the library or library system. The full text of HB2789 is appended to this report.
 - The Park Ridge Public Library's Collection Management Policy states, the Library Board of Trustees endorses the American Library Association's Bill of Rights and the Freedom to Read and Freedom to View Statements.
 - The Illinois State Library will develop administrative rules in the coming weeks that will guide libraries on how they can comply with the new law. RAILS will facilitate feedback for member libraries in the coming weeks.
- The Library received one FOIA request in May 2023:
 - o Requestor: Margie Nanninga
 - This is a FOIA for all events hosted at the Park Ridge Public Library between June 1, 2022 and May 25, 2023 for teens including events targeted at middle school and high school students. I would like to see 1) the attendance and/or registration numbers for each event and 2) all expenses associated with hosting the events including invoices and any internally used budgeting tools/trackers/outputs.

Staff Updates and Professional Development:

- Assistant Patron Services Manager, Matthew Hoffman has accepted a new position with Wilmette Public Library as their Circulation Manager! We wish Matthew the very best in his new role. Patron Services Manager, Anastasia Rachmaciej is in the process of interviewing candidates for the Assistant Patron Services Manager position.
- Ms. Rachmaciej will serve as Secretary on the CCS Circulation Technical Group.
- Technical Services Manager, Lauren Bochat will serve a fourth and final term as Chair of the CCS Catalogers and Metadata Management Technical Group.
- All Library staff are working on Cyber Security training deployed by CVI.

Strategic Plan Progress:

- Encourage individual growth and lifelong learning
 - Lead Green as a convener, researcher and public example.
 - Adult Services Manager, Laura Scott, applied for and was awarded a \$500 grant from the Solid Waste Agency of Northern Cook County (SWANCC). The goal of the grant program is to provide funds that assist libraries to purchase material resources that promote reducing our carbon footprint; benefits of waste prevention, reduction, and reuse, recycling, and composting initiatives within the community.
 - This award will be used to purchase a thermal camera for patron checkout as part of our Exploration Library offerings. Thermal cameras are used to assess hot and/or cold spots in homes as first step in taking steps to address wasted energy. It is our hope that adding this unique item will increase awareness of energy efficiency measures residents can take in their homes.
 - Additionally, grant award recipients agree to host a SWANCC education presentation, topic and format will be mutually agreed upon by PRPL and SWANCC.
 - Also in May, the Youth Services Department hosted patron and local composting expert Amy Bartucci (member of Go Green Park Ridge) to present an *All About Composting* program to kids to teach them what composting is, how it works and why it is so good for the earth.
- Build up a strong workforce and local businesses
 - The Adult Services department hosted *Get Hired: Career Brand Phrases that Stick* program on May
 9. Sixteen patrons attended.

• Align with strategy and set the stage for development

• Library Administration and Board have been working on significant revisions to the Library's Employee Handbook.

• Develop Civic Education for an informed and engaged citizenry.

Teen Services Librarian, Emily Fardoux, convened the first meeting of the Teen Advisory Board (TAB) on May 23. The group is a mix of 12 middle and high school students all citing in their application a desire to "help my community," "be more active in the library," and "gain leadership experience." During their first meeting, Ms. Fardoux conducted a SWAT analysis exercise discussing the strengths, weaknesses, opportunities, and threats that they observed with Teen Services at the Library. The group then brainstormed fall program ideas and ways the Library can get the word out to teens. Ms. Fardoux was impressed with the thoughtfulness of the participants and energized by their excitement to be on TAB.

Finance and Human Resources

- Finance and Administrative Services Manager, Alyson Doubek and I attended a virtual HR Source presentation on the new *Paid Leave for All Workers in Illinois* law on June 6. The new law takes effect on January 1, 2024. Based on advice from HR Source, we are going to wait until the fall to draft a policy for Board approval. It is anticipated that the IL Department of Labor will issue additional guidance closer to the law's implementation date.
- Ms. Doubek and I met with Personnel Committee Chair Rapisand and President Hanba on June 12 to review the final section of the employee handbook. The draft will be brought to the July 11 Committee of the Whole for review and discussion.
- The Library received its \$50,000 check from the IL State Library for the Live and Learn Grant disbursement.

Building and Grounds:

- Facilities Manager, John Priala, and CVI System Engineer, Tim Brzny, have been coordinating with AT&T and Airespring. The City of Park Ridge issued a permit to AT&T (June 19-June 30) to complete the infrastructure work needed to migrate the Library's copper lines to Airespring's fiber circuit.
- Mr. Priala and Mr. Brzny are continuing to work with Comcast on the logistics for our fiber internet circuit upgrade.
- Anthony Roofing completed their annual spring roof inspection on May 4. Minor repairs were made to the gutters in the southeast corner of the building.

Partnerships, Outreach and Advocacy

Our Youth Services Department staff were out and about in May promoting Summer Reading Clubs. Led by our school liaisons, Preschool Coordinator Liz Fichter, Elementary School Coordinator Catherine Dudley, and Middle & High School Coordinator Maddie McGuire, members of the Youth Services team presented 152 sessions to 5,502 kids and teachers. This level of high touch outreach has a direct impact on the success of our program. As a result of the team's efforts, 881 kids and teens signed up for Summer Reading in May.







- Twenty Library staff members and their families represented the Library at the 100th Anniversary Park Ridge Memorial Day Parade. It was a beautiful day and always fun to hear and see support for our Library in the community. Thank you to Vice President Kiem for joining us on Memorial Day.
- Marketing/PR Coordinator Jen Healy, Laura Scott, and I attended the semi-annual meeting of the Friends of the Park Ridge Public Library on June 7. Ms. Healy has been working with the FOL President and Membership Chair to further promote the Friends and attract new members.



Marketing/Public Relations

- The summer newsletter arrived in homes on May 25.
- Our second annual *Live on the Lawn* event on Saturday, June 10 was very successful. Approximately 300 patrons of all ages joined us for an afternoon of music, ice cream, and summer reading excitement. Thank you to Trustee Rapisand for volunteering for this event. Some statistical highlights from the day include:



- 19 patrons were registered for new Library cards, compared to seven registrations on Saturday, June 3.
- o 1,595 items were checked out, compared to 929 on Saturday, June 3.
- Door count was 1,517, which topped the busiest Saturday of 2019 at 1,063.

Notable Programs, Collections, and Services:

 On May 12, we welcomed 32 Library volunteers to the first Volunteer Appreciation Tea since 2019. It was a wonderful opportunity not only to thank our volunteers but also to speak with them about all the ways the Library makes a difference in their lives. The tea was an interdepartmental collaboration lead by our Volunteer Coordinator, Kelly Mayer, with support from Mary Mason (Youth Services), Laura Muresan (Patron Services), and Cathy Thompson (Adult Services).



 The Loft summer hours started on Monday, June 12. The Loft is now open starting at 11 AM, Monday-Friday. Weekend hours remain unchanged.
